NEW BUSINESS

Girl Scout Gold Award project request

A representative from Girl Scout Troop 2154 came to present a project called "Doing Your Best: Mental Health Awareness." The goal of the project would be to raise awareness about mental health, help youth recognize the signs of declining mental health, and help students raise self-esteem with a mural on a canvas designed to inspire them. She would also create inspirational bookmarks. The Board discussed the need to have attribution for the quotes or choosing phrasing that is in the public domain. The Board has postponed the decision until the Director is available and can introduce the student to the social worker, who can offer advice and guidance on connecting creative expression to mental health. The Board liked the idea but would want approval of all designs and quotes and would retain final approval of location and length of time that the canvas would be displayed. The Board also clarified that any fundraising would need to be disconnected from the library.

Request to fund staff holiday party

The Board voted to fund the staff holiday party from the gift fund with a limit of \$1,000.

Change prior approval of Verizon donation/Discuss proposed use for recent donation in honor or Mary Arnold

This conversation was postponed until next month.

Discussion on security for the library

The Board discussed the idea of police officers potentially doing walk-throughs as part of patrol. Some of the questions that the board had was whether there were organizational policies on police in libraries and the policies and practices of other libraries.
